Creative Communities 2025–2026 (Creative Black Country)

- **What it offers:** Creative commissions of up to **£1,000** for community-led initiatives—like learning a new craft, starting a choir, creating a garden gallery, or “go and see” cultural visits to shows, museums, or galleries.
- **Who is eligible:** Community groups, particularly those:
 - Engaging in creative activities for the **first time**
 - Located in **priority areas** across the Black Country:
 - **Dudley:** Brierley Hill, Kingswinford, Halesowen, Stourbridge & Sedgley
 - **Sandwell:** Rowley Regis, Tipton, Oldbury & Wednesbury
 - **Walsall:** Willenhall, Bloxwich, Darlaston & Brownhills
 - **Wolverhampton:** Bushbury, Heath Town, Blakenhall, Ettingshall & Spring Vale
- **Deadline:** All projects and activities must be **completed by 28 February 2026**

Heart of England Community Foundation - The Birmingham Sports Fund (Birmingham)

The Heart of England Community Foundation is a local independent grant making organisation which aims to improve the quality of life of disadvantaged people living in the West Midlands, by awarding grants for specific activities to community-based voluntary groups on behalf of a wide range of donors. Through the Birmingham Sports Fund, the Foundation provides grants of up to £1,000 for projects that encourage more people in Birmingham to be active and engage in sport. In particular, the fund aims to support projects that encourage sports participation from disadvantaged communities, Black, Asian and minority ethnic communities, women and girls, and disabled people. **Applications can be submitted at any time.**

Heart of England CF - Tipton Education Fund (Tipton, Birmingham)

To support schools and community projects in Tipton. William Perry, known as “The Tipton Slasher”, was a legendary heavyweight boxer who became Champion of England twice. Themes: Overcome barriers to learning, Raising aspirations of children and young people, Supporting family learning and encouraging healthy living, Encouraging and supporting children to read, Providing enrichment opportunities for children, young people and families. Small grants of up to £3,000 pa for projects to be delivered within a 12-month period. Large grants of up to £10,000 pa for collaborative projects to be delivered within a 24 month period. Open to most non profits. **No deadline.**

Birmingham City Council Public Health Funding for Community Organisations (Birmingham)

Birmingham City Council Public Health has launched the Birmingham Inclusion Health Grants Programme, offering grants of up to £20,000 to support community-led, trauma-informed projects that improve health outcomes for some of the city’s most underserved communities.

The programme is designed to support work with inclusion health groups, including:

- Sex workers
- Veterans
- Women from inclusion health groups
- Men from inclusion health groups

These communities often experience multiple and overlapping challenges, such as stigma, discrimination, poverty, violence and complex trauma. This funding aims to help organisations deliver compassionate, inclusive and effective responses to these issues. **Application deadline: Friday 13th February 2026**

The Saintbury Trust (West Midlands, with focus on Birmingham and Worcester)

Arts, heritage, the environment and helping those with disabilities. £1,000 - £5,000. Larger grants tend to be awarded to charities of which the trustees have special knowledge or in the work of which they have a particular interest. **Ongoing**

Birmingham and Black Country Communities Fund (Birmingham & the Black Country)

The Birmingham and Black Country Communities Fund has now reopened! The fund has grants up to £3,000 and aims to support people in Birmingham and the Black Country. Applications must meet one of the following aims:

- Promote health and wellbeing
- Tackling disadvantage
- Support local solutions to meet local needs
- Promote community cohesion
- Develop sustainable and supporting communities

The Barrow Cadbury Trust Grants Programme (Birmingham and the Black Country)

Committed to supporting vulnerable and marginalised people in society. The Trust promotes social justice through grant making, research, influencing public opinion and policy and supporting local communities. Their work is divided into three programme areas: Criminal Justice - building evidence of effective interventions, primarily for young adults and women, at all stages of the criminal justice process; Migration - promoting an immigration system that is fair to both migrants and established residents; Economic Justice - supporting effective approaches to reducing economic and social injustice and assisting in building resilient communities. There is a particular focus on projects located in Birmingham and the Black Country. **Applications can be submitted at any time.**

Coventry, Solihull & Warwickshire (CSW) Communities Fund

The **Coventry, Solihull & Warwickshire Communities Fund** grants are awarded from the earnings of the Foundation's own endowment fund. There are grants of up to £3,000 available to support people in Coventry, Solihull and Warwickshire. Applications must meet one of the following aims:

- Promote health & wellbeing
- Tackling disadvantage
- Support local solutions to meet local needs
- Promote community cohesion
- Develop sustainable & supporting communities

Natural Networks Programme (Malvern Hills, Wychavon or Wyre Forest)

Offering grants and advice to projects which aim to create/restore wildlife-rich habitats. It is a partnership between Worcestershire County Council and Worcestershire Wildlife Trust, offering free professional Biodiversity surveys carried out by the Trust who will assess your project site and make recommendations on how to create or enhance your land to maximise habitats for wildlife. Grants of £1,000 - £15,000 are available (up to 70% of the total project will be available to help you carry out recommendations in the survey).

- Private sector organisations will be expected to match fund at least 50% of the project
- Public or voluntary sector organisations will be expected to match fund at least 30% of the project

Herefordshire Community Foundation - CPRE (Herefordshire)

The Herefordshire Community Foundation exists to benefit disadvantaged communities by making grants to support relevant charitable or voluntary organisations, which make a difference to their local communities. Through the CPRE programme, the foundation provides funding to organisations working to preserve and support the tranquility of Herefordshire's countryside. **Applications can be submitted at any time.**

Herefordshire Community Foundation - Iron Fund (Herefordshire)

The Herefordshire Community Foundation exists to benefit disadvantaged communities by making grants to support relevant charitable or voluntary organisations, which make a difference to their local communities. Through the Iron Fund the foundation provides grants to relieve the needs of people in Herefordshire, favouring projects that encourage community cohesion, or address issues of isolation and disadvantage. **Applications can be submitted at any time.**

Herefordshire Community Foundation - Hergest Fund (Kington area)

The Herefordshire Community Foundation exists to benefit disadvantaged communities by making grants to support relevant charitable or voluntary organisations, which make a difference to their local communities. Through the Hergest Fund the foundation provides funding support to welfare, educational and environmental activities. **Applications can be submitted at any time.**

Herefordshire Community Foundation - George's Fund (Herefordshire)

The Herefordshire Community Foundation exists to benefit disadvantaged communities by making grants to support relevant charitable or voluntary organisations, which make a difference to their local communities. Through George's Fund the foundation provides funding for projects aimed at children aged 3 to 11 years old in Herefordshire. **Applications can be submitted at any time.**

Herefordshire Community Foundation - Glencora (Herefordshire)

The Herefordshire Community Foundation exists to benefit disadvantaged communities by making grants to support relevant charitable or voluntary organisations, which make a difference to their local communities. Through the Glencora programme the foundation provides support to organisations that aim to increase environmental awareness or who are active in environmental support and those working with the older generation. **Applications can be submitted at any time.**

Crowdfund Shropshire (Shropshire)

Crowdfund Shropshire, the new civic fundraising platform where community groups can get their projects funded by public and grant funding, is opening in the next month. Projects can bid for up to £10,000 from the Shared Prosperity Community Fund and up to £20,000 from the Green Spaces and Active Travel Fund. Currently 5 projects crowdfunding at the moment. They include Rural Art Hub, Walking in Wem, Multicultural Children's Day, Little Stars in the Community and Get Crafty With Words. Staffordshire Community Foundation - The J&O Lloyd Community Grants Fund (East Staffordshire)

The Staffordshire Community Foundation exists to benefit disadvantaged communities by making grants to support relevant charitable or voluntary organisations, which make a difference to their local communities. Through the J&O Lloyd Community Grants Fund the foundation provides grants of up to £10,000 to organisations who provide benefit to a community within the East Staffordshire borough. Preference will be given to applications working in one of the following fields; Heritage; Arts & Leisure; Built & Natural Environment; Social & Community Isolation. **Applications submitted between 1st October and 31st March will be considered at a panel meeting in April.**

National Forest Company - Small Grants Fund (Leicestershire, Derbyshire, Staffordshire)

Through the National Forest Small Grants Scheme funding is available to support projects that contribute to the aims and objectives of the National Forest. Those who operate within the Forest area can apply for grants to support a range of projects and activities. **Applications can be submitted at any time.**

The Edward and Dorothy Cadbury Trust (West Midlands)

Funding is available for charitable organisations in the West Midlands working in the areas of social welfare, music, nature, education and training combined with the Quaker values of simplicity, equality, justice, peace and care of the environment. Grants are available of between £1,000 and £5,000.

Applications can be submitted at any time.

npower Business Solutions Foundation (West Midlands)

Aims to support not-for-profit organisations and educational institutions located within a 50-mile radius of their Solihull (B91 3ES) and Leeds offices in creating sustainable communities. The foundation offers grants of up to £100,000 for projects focused on decarbonisation, responsible business growth, social innovation, and local skills/employment promotion. Projects that help to improve the environment, forge stronger community bonds, encourage responsible business and improve places and spaces. **Applications can be submitted at any time.**

Forestry Commission - Tree Health Pilot Scheme (focus on West Mids)

The Scheme is testing ways to slow the spread of pests and diseases affecting trees in certain regions of England. Eligible trees include larch, spruce, sweet chestnut, oak, and ash affected by various diseases. The grants cover activities such as woodland management and tree maintenance. To be able to participate, the woodland needs to be located in North West England, the West Midlands or the South East and London. individuals or groups. **Applications can be submitted at any time.**

Severn Trent Community Fund (East Midlands, West Midlands, South West)

Voluntary or community organisations in the Severn Trent Water region are eligible to apply to the £10 million Severn Trent Community Fund for funding to increase community wellbeing. This includes support for projects that help people to lead a healthier life and gain new skills; help to create better places to live in and use; and Projects that will help look after the natural environment, give people greater access to that environment or help look after water.

Applications can be submitted at any time.

UK/England Wide:

The Delamere Dairy Foundation (England, Scotland and Wales)

Funding local projects that help strengthen communities across England, Scotland and Wales by making grants to support not-for-profit organisations that make a difference within their local area. Grants are available for projects that benefit communities through the advancement of agriculture and environmental protection, by improving the lives of young people and education, and relieving financial hardship and sickness. **Closing date for applications is 31st January.**

Inman Charity (UK)

Grants totalling £250,000 per year are available to registered charities in the UK for projects with a social welfare focus and those working with disadvantaged people. The Directors are particularly interested in supporting the following areas of charitable work: Medical research; care of the elderly; general welfare; hospices; the deaf and blind; care of the physically & mentally disabled; and the Armed Forces. **The closing date for applications is 31st January 2026.**

The 7stars Foundation – Social Impact Funding (UK)

The 7stars Foundation provides grant funding to small charities supporting young people aged 18 and under in the UK who are affected by abuse, addiction, homelessness, or caring responsibilities. Under its Social Impact Funding stream, the Foundation awards two-year unrestricted grants of £10,000 (£5,000 per year) to organisations addressing key societal issues impacting young people, such as child exploitation, mental health, LGBTQ+ inclusion & support, anti-racism, and online abuse. One charity is supported per issue each year. **Closing date for applications 1st February 2026.**

RBG Kew: Grow Wild – Community Programme 2026

We're seeking 23 groups from across the UK to join the programme in 2026. Is your community group ready to... Connect local people with nature? Transform an urban space with planting? Learn more about UK native plants and fungi? Grants of £2,000 (plus a potential £500 follow-on grant in Spring 2027) to UK-based community or youth groups for projects that transform local urban spaces using native UK plants or fungi. Online knowledge sharing sessions are on offer to connect with other groups and get support from experts. Eligible applicants must be constituted groups able to manage funds and deliver activities between April and October 2026, with a strong emphasis on inclusion and environmental impact. **Applications close at 3pm on 4th Feb 2026.**

FCC Communities Foundation (England)

Helps benefit the lives of people who live close to landfill sites by awarding grants for community, biodiversity and heritage projects. The FCC Community Action Fund is designed to deliver amenity projects within 10 miles of a FCC Environment landfill site in FCC Communities operating area. The following types of amenity can be funded: Village Halls, community centres, public play areas, multi sport games areas, sport and recreation grounds, churches, nature reserves, public gardens and woodlands, Museums. Funding is available of between £2,000 and £100,000 for projects with a maximum total project cost of £500,000. **The closing date for applications is 11th February 2026.**

The Idlewild Trust (UK)

Supports registered charities concerned with the encouragement of the performing and fine arts and crafts and the preservation for the benefit of the public of lands, buildings and other objects of beauty or historic interest in the United Kingdom. The Trust awards around £140,000 each year in grants and considers making grants of up to £5,000. In 2020 Idlewild Trust awarded 33 grants totalling £128,055, an average of nearly £3,880. **Closing date for applications 13th February 2026.**

Stanley Smith Grants to Promote Horticulture and Public Gardens (UK)

Organisations involved in horticulture, gardening, or botany can apply for grants of up to £5,000 from the Stanley Smith (UK) Horticultural Trust. The Trust supports projects that promote horticulture, conserve the environment through biodiversity, develop public gardens, and advance horticultural education. Eligible projects include the restoration of historic gardens, creation of new public garden spaces, horticultural research, publications, and plant study expeditions. The grants aim to enhance public access to gardens, promote horticultural knowledge, and conserve plant diversity. Grants are normally awarded twice a year, in April and September (following **application deadlines of 15th February 2026 and 15th August 2026**).

Enovert Community Trust (UK)

Enovert Community Trust (formerly Cory Environmental Trust in Britain) is an Environmental body which supports community and environmental projects. The Trust awards grants under the terms of the Landfill Communities Fund (LCF), providing funding to a broad range of projects that have a positive impact on local communities. The Trust is committed to supporting community and environmental projects across the UK. These include improving community halls, the creation of new play areas and skate parks, and restoring green spaces. Fundraising by applicants is looked upon favourably by the Trustees. Applicants will need to secure a 10% third party contribution which will be payable to Enovert Limited prior to the project commencing. **The closing date for applications is 27th February 2026.**

The Kelly Family Charitable Trust (UK)

The Kelly Family Charitable Trust was founded in 2004 as a grant-giving body. The Trust is interested in funding charities whose activities involve the whole family in initiatives that encourage and nurture a supportive structure within the family unit, and whose aims include the development of strong and supportive family bonds by helping all elements of the family unit to grow together and support each other. Applications are also welcomed from sports and health-related charities whose activities meet the trust's criteria. Grants of between £1,000 and £5,000 are available, but higher grants may be considered. **The closing date for applications is 1st March 2026.**

Learning Through Landscapes - Local Schools Nature Grants Scheme (England, Scotland & Wales)

The Local Schools Nature Grants Scheme allows schools in England, Scotland & Wales to apply for £500 worth of outdoor resources, and a two hour training session. Operated by Learning through Landscapes, the scheme is funded by Postcode Local Trust which receives funding from players of People's Postcode Lottery. Schools with pupils aged 5+ and are passionate about making environmental improvements for the benefit of their pupils, staff and the community can apply to receive equipment to the value of £500 selected from a list of 72 items. Ideal partners will include children in decision making and incorporate their local community. **Closing date is 13th March 2026.**

The Matthew Good Foundation - Grants for Good (UK)

The Matthew Good Foundation's Grants for Good aims to support small charities, not-for-profit groups and social entrepreneurs who are passionate about making a difference to people, their community or the environment. The Fund will share £15,000 between five shortlisted projects every three months, which will be voted for by John Good Group employees. The project that receives the most votes will receive a grant of £5,000, second place £3,500, third place £2,500 with fourth and fifth place both receiving £2,000. As well as established projects and charities, the Foundation wants to hear from people with innovative ideas that need some funding to get their projects up and running. **The closing date for applications is 15th March 2026.**

Veterans Foundation Grant (UK)

Armed Forces charities and other not-for-profit organisations can apply for grants of up to £40,000 for projects and activities supporting serving armed forces personnel, veterans, operationally qualified seafarers and their immediate families. **The closing date for applications is 30th March 2026.**

Crowdfunder - Energy Efficiency Sharematch (England)

The Energy Efficiency Sharematch Fund aims to help community organisations in England to reduce their energy usage and carbon footprint. It can be used to install on-site energy generation measures like solar panels and heat pumps, improve building energy efficiency through insulation and LED lighting, and upgrade operational equipment to more energy-efficient alternatives. **The closing date for applications is 31st March 2026.**

Grants to Improve the Lives of Disadvantaged People (UK)

Members and colleagues of the Yorkshire Building Society can nominate UK Charities to apply to the Yorkshire Building Society Charitable Foundation's Small Change Big Difference Fund. The Foundation aims to help alleviate poverty, improve health, and save lives. Once nominated, organisations can apply for grants of up to £2,500 to support initiatives that benefit vulnerable groups in the UK, including children, the seriously ill, the elderly, the homeless, and people with disabilities. Priority will be given to organisations with an annual income under £100,000 and those supporting marginalised communities. To access the funding, charities should consider encouraging supporters who are members or colleagues of the Yorkshire Building Society to nominate them for potential funding opportunities. **The next application deadline is 31 March 2026**

Grants for Environmental and Social Wellbeing Projects (UK)

UK-registered charities can apply for grants to support projects that improve the environment, strengthen communities, or promote wellbeing. The funding is provided by the Calisen Impact Charitable Trust. The Trust supports community projects that encourage sustainable energy use and promote inclusive, safe, and diverse places to learn and work. Past projects include partnerships with Eco-Schools, which help schools gain Green Flag accreditation and engage children in environmental action. The Trust has also supported Youth Zones, which provide nutritious meals for disadvantaged young people. The Trust has not specified a total fund value or maximum grant amount. **The next application deadline is 31 March 2026.**

Matrix Chambers - Matrix Causes Fund (UK)

The Matrix Causes Fund, administered by Prism, provides funding for registered charities supporting the needs of vulnerable people across the UK. One-off grants of up to £5,000, or grants of up to £3,000 a year for 3 years, are available to support organisations that promote access to justice (particularly for people trying to get support to meet their basic personal needs), equality of opportunity, or a sustainable environment. The funding can be used for core activities that support vulnerable persons such as prisoners, asylum seekers, people with mental health difficulties, people (particularly children) with disabilities, or women in refuges. There are two funding cycles in a year. Each application cycle will have a maximum of 30 applications accepted for funding. **The closing date is 31st March 2026.**

Sasha Foundation (UK & International)

Grants of up to £10,000, or 50% of a project's budget, to established charitable organisations supporting young people with mental health or drug issues, particularly for young women. **Closing date for applications is 1st April 2026.**

Aviva Foundation funding

The Aviva Foundation is a UK-wide fund supporting charities working on financial resilience and community-led climate action. The Foundation offers two main types of funding:

- Financial Futures Fund – Multi-year grants for larger UK charities (with annual income of £1 million+) working to tackle financial insecurity and help people build financial resilience.
- Communities Fund – Supports smaller local charities and community organisations (with annual income of £1 million or less) with projects that improve financial wellbeing and address climate action. It uses a matched-funding approach (Aviva matches public donations up to a set amount). **Deadline: closes 15 April 2026**

NIHR National Institute For Health and Care Research (NIHR). Public Health Research. Greenspace and Natural Environments (UK)

The Public Health Research (PHR) Programme is looking to fund research which evaluates the health impacts of the interventions which change access to green and blue space. This is a 2-stage funding opportunity. To apply for the first stage you should submit an outline application. If invited to the second stage, you will then need to complete a full application. **Closing date 21 April 2026 at 1:00 pm**

England Woodland Creation Offer (England)

To support woodland creation and tree planting across England. Landowners, land managers and public bodies can apply to the England Woodland Creation Offer for support to create new woodland, including through natural colonisation, on areas as small as 1 hectare. The grant will cover standard capital costs for tree planting (up to a per hectare cap), as well as rewarding farmers and landowners for providing public and/or wider environmental benefits. **Closing date 31st May 2026.**

Woodland Trust - Free Trees (UK)

Free tree packs to give away to schools, community and youth groups, available for planting on one publicly accessible site. First come first serve basis. All applicants need to do is find a suitable site and supply the volunteer planters and tree protection. Tree packs for schools and communities offer the perfect opportunity to bring people together to plant trees - encouraging local wildlife, protecting our landscape against tree disease and creating beautiful wooded areas that people can enjoy for years to come. **Applications expected to close in August 2026, with delivery of tree packs in November 2026.**

Orchards for Schools (UK)

The Tree Council is the UK's lead charity for trees, promoting their importance in a changing environment. The trees for schools grant is open to all schools within the United Kingdom with pupils aged 16 or under. The Tree Council will fund up to 4 fruit trees (but no more than that) on semi-vigorous, vigorous and very vigorous rootstocks. If you wish to plant more than 4 fruit trees, please apply to our [Orchard Windfalls Fund](#). Projects must fall between £100 and £700 and children under the age of sixteen must be actively involved in the planting process. **Applications can be submitted at any time.**

The Stobart Group - Stobart Sustainability Fund (UK)

The Stobart Sustainability Fund supports community-led environmental and sustainability projects across the UK. It focuses on initiatives addressing climate change, reducing carbon emissions, and protecting the environment. The fund is open to not-for-profit organisations, community groups and educational facilities, such as schools and colleges. **Applications can be submitted at any time.**

Trusthouse Charitable Foundation - Small Grant (UK)

The Trusthouse Charitable Foundation is a grant making foundation that give grants to small and medium sized local organisations in the UK with a demonstrable track record of success working to address local issues in communities of extreme urban deprivation and deprived rural districts. Through the small grants programme the foundation provides funding of between £2,000 and £10,000 to charitable organisations with an income of less than £250,000 for projects that focus on Community Support. Examples of the kind of projects that can be funded include: Community Services; Community Centres; Alternative Education; Training, mentoring, employment and volunteering opportunities; Youth; Counselling; Family Support Services; Substance Misuse. **Applications can be submitted at any time.**

Bernard Sunley Foundation - Health Grants (England and Wales)

The Bernard Sunley Foundation aims to raise the quality of life in England and Wales, particularly for the young, disadvantaged and older people. Through the Health funding strand, the Foundation supports building and refurbishment projects, specialist new transport and the creation of outdoor or recreational spaces for care homes, hospices, day centres and other facilities that provide relief and sanctuary for patients, their families and those with special needs. The emphasis is on helping charities that are providing an excellent standard of care and support within their communities.

Applications can be submitted at any time.

Bernard Sunley Foundation - Education Grants (England and Wales)

The Bernard Sunley Foundation aims to raise the quality of life in England and Wales, particularly for the young, disadvantaged and older people. Through the Education funding strand, the Foundation supports improvements and new facilities at special needs schools and the purchase of new, adapted minibuses that benefit children with special needs and disabilities. The Foundation also awards grants to educational nature centres and to new education and learning centres at museums, galleries and other arts organisations. **Applications can be submitted at any time.**

Persimmon Community Champions (England, Scotland and Wales)

Providing grant funding of up to £1000 to registered charities, clubs, schools and other organisations which have already raised vital funds themselves towards projects to enhance their local community. The type of projects supported to date have included support for foodbanks; projects within schools; and sports projects; etc. **Applications can be submitted at any time.**

Wooden Spoon Society Grant (UK)

Schools, charities and community organisations can apply for grants for projects that improve the quality and prospect of life for children and young people who are disadvantaged physically, mentally or socially including those Not in Education, Employment or Training (NEET). Grants available include capital projects such as medical treatment and recovery centres, sports and activity areas, sensory rooms and gardens, playgrounds and hydrotherapy pools as well as revenue grants to support outreach programmes for children in their communities. **Applications can be submitted at any time.**

Rayne Foundation Grants Programme (UK)

The Rayne Foundation offers grants to tackle entrenched social issues through the arts, health, wellbeing, and education. The foundation has a particular focus on connecting communities, building bridges between marginalised groups and mainstream society, and enabling individuals to reach their full potential. The annual grant making programme is in the region of £1.5 million and grants typically fall in the range of £10,000 to £20,000 per annum for up to three years. Funding is available both for capital and revenue expenditure. **Applications can be submitted at any time.**

John Ellerman Foundation - Environment: People and Planet (UK)

The John Ellerman Foundation's People and Planet funding scheme provides grants to charities that work to promote a healthier environment for both people and nature. The scheme prioritises projects that enhance ocean health through stronger marine protected areas and on land and in freshwater through sustainable management, habitat restoration, and landscape-scale conservation. The scheme also aims to address the impact of human activities like climate change and pollution on air, land, and water. **Applications can be submitted at any time.**

The NINEVEH Charitable Trust (UK)

The NINEVEH Charitable Trust supports a broad range of UK based projects and activities that promote: The health, welfare and education of the general public; The study and appreciation of agriculture, horticulture, silviculture and land and estate management; The study and appreciation of ecology & land conservation; The study and appreciation of forms of agricultural practice or land management that would encourage the preservation of the countryside. UK Registered charities and Community Interest Companies can apply for one-off payments or funding to support longer-term more complex projects. **Applications can be submitted at any time.**

Rhododendron Trust (UK)

Grants of £1,000 to £2,000 to registered charities supporting the disadvantaged in the developing world and the UK and to those supporting the arts and wildlife. Smaller Charities are prioritised. In the UK, support is given to charities working with those disadvantaged by disability or mental illness; prisoners and ex-offenders; drug addiction; homelessness; carers; the elderly; disadvantaged children. Arts and Nature funding is mainly through the National Churches Trust and Fauna and Flora International, however proposals for small theatre and music projects, for the protection of cultural and natural heritage or environmental sustainability are accepted. **Applications can be submitted at any time.**

National Lottery Community Fund: New Climate Action Fund strand on strengthening food systems

Food sits at the heart of our health, our communities and our environment. But too often, food insecurity, environmental damage and inequality are tackled separately. The National Lottery Community Fund's Climate Action Fund strand on food is looking for ambitious, long-term projects that strengthen food systems, tackle the root causes of food insecurity and work with nature to create lasting change. Now looking for partnerships and organisations that already have the skills, relationships and infrastructure to work at scale to lead transition to food systems that are fairer, more resilient and better for people, climate and nature.

Swire Charitable Trust (UK)

The Swire Charitable Trust makes grants to charities supporting some of the UK's most vulnerable people to overcome barriers and realise their potential, and to charities who are protecting the environment and heritage. **Applications can be submitted at any time.**

Bernard Sunley Charitable Foundation - Community Grants (England and Wales)

The Bernard Sunley Foundation aims to raise the quality of life, particularly for young, disadvantaged and older people. Under the Community Funding strand the Foundation gives grants towards the building or refurbishment of scout huts, village halls, community centres, youth clubs, boxing clubs, outdoor activity centres, farm and outdoor learning centres, sports centres and pavilions, playing fields and playgrounds. The Foundation also fund the purchase of new minibuses that assist those most in need in their local communities. **Applications can be submitted at any time.**

Wakeham Trust (UK)

The Wakeham Trust is a grant making organisation that support organisations and registered charities as well as small community and voluntary groups within the UK that want to improve their communities. The Trust is particularly interested in supporting projects that are small scale and would find it hard to get funding from big trusts; or are currently unfashionable or unpopular amongst mainstream funders, but are making a real contribution. The Trust is particularly looking to support projects where funding of between £125 and £2,500 can make a real difference. **Applications can be submitted at any time.**

Historic England – People: Funding for Activities that Help People Understand & Champion the Historic Environment (England)

Historic England offers grants to support charities, community and voluntary groups, and other organisations to deliver activities that help people understand and champion the historic environment. This funding focuses on projects that involve people in heritage, particularly marginalised or under-represented groups, through engagement, skills, training, education and heritage project-based posts. **Applications can be submitted at any time.**

Social Investment Business - Community Builders Fund (England, Scotland & Wales)

The Community Builders Fund, delivered by Social Investment Business, offers loans ranging from £100,000 to £1.5 million to support the growth and long-term resilience of organisations working to improve people's lives or the environment they live in. Loans are repayable over six years at a fixed rate of 7.9% per annum. There is the potential for up to 12 months of interest-only payments, with no early repayment charges. **Applications can be submitted at any time.**

The Tree Council - National Highways 3 Million Trees Project (England)

The Tree Council is helping National Highways plant 3 million trees by 2030 by gifting up to 600,000 trees to communities across England annually. The initiative aims to benefit both nature and communities through low carbon tree planting. A selection of tree species, with orders of between 2,500 to 50,000 whips available to a wide range of applicants, including charities, farms, education institutions and more. **Applications can be submitted at any time.**

England's Community Forests: Trees for Climate grants (England)

Trees for Climate is a multi-million pound woodland creation programme. Trees for Climate is delivered by the 13 Community Forests across England, who have extensive experience in supporting landowners to establish and manage woodlands. Trees for Climate grant funding can cover the costs of woodland creation, fencing, paths and other infrastructure, and ongoing maintenance for up to 15 years. Design, planning and planting support from professional woodland advisors is also available. **Applications can be submitted at any time.**

The National Lottery Community Fund – Partnerships Grant (England)

The National Lottery Community Fund distributes money raised by the National Lottery to support local communities. The Partnerships funding programme provides grants of over £20,001 for projects to increase collaborative working between organisations and can support many different types of partnership, including cross-sector partnerships, local place-based collaboration, local and national organisations working together around a theme. Projects must meet one of the following funding priorities: bring people together and build strong relationships in and across communities; improve the places and spaces that matter to communities; enable more people to fulfil their potential by working to address issues at the earliest possible stage. **Applications can be submitted at any time.**

Historic England - Places: Funding for Activities that Repair, Conserve & Care for Heritage (England)

Historic England offers funding to support projects that repair, conserve, and care for historic places, including listed buildings, monuments and landscapes. This funding programme helps heritage sites become more resilient, accessible, and inclusive, especially those most at risk. Grants are primarily awarded for urgent repairs or other work required to address risk by preventing loss or damage to important architectural, archaeological or landscape features. **Applications can be submitted at any time.**

National Garden Scheme - Professional Development Grants (UK)

The National Garden Scheme Professional Development Grants aim to enhance the quality of care provided to hospice patients, their caregivers, and families. The grants focus on supporting hospice staff to improve patient outcomes through professional development opportunities. Eligible areas in the UK include hospices that are members of Hospice UK located in the UK, Channel Islands, or Isle of Man. Applications must be received at Hospice UK at least one month before the start of the course or module. **Applications can be submitted at any time.**

Ernest Cook Trust - Outdoor Essentials Grant (UK)

The Ernest Cook Trust is an educational charity who aim to help the nation better understand the environment. Through the Outdoor Essentials Grant is a £500 award to UK State funded Primary and Secondary Schools to enable them to get their pupils learning outdoors. **Applications can be submitted at any time.**

Jephcott Charitable Trust Grant (UK)

The Jephcott Charitable Trust makes grants for charitable purposes in four main areas of funding: population control, the environment, education and health. Preference will be given to charities or projects which are having difficulty getting started, or raising funds from other sources. This often means that the Trust is funding capital projects, e.g for equipment or materials, rather than running costs. Grants are made to charities in all parts of the world. The Jephcott Charitable Trust does not support projects involving animal welfare or heritage sites or buildings. Projects which require long-term funding not normally considered. Applications are considered at trustee meetings in April and October. **Applications can be submitted at any time.**

Biffa Award Main Grants Scheme (England, Wales and Northern Ireland)

Biffa look to award grants to projects that provide or improve biodiversity, nature recovery, community spaces, cultural facilities, and places for outdoor recreation. The type of activities could be to improve community buildings; site-based projects to protect and enhance a species or habitat; improving an open space such as a park, play area or woodland that needs transforming to benefit local people of all ages. Between £10,000 and £75,000 is available for projects of less than £200,000. Ten percent of the award needs to be third party sourced. **Applications can be submitted at any time**

Marsh Trust Grant (UK)

The Trust provides grants to registered charities working in the fields of social welfare, literature arts and heritage, environmental and animal welfare, education and training. Grants range from £300 to £2,000. Must be UK-based registered charities experienced in their field of work in any of the above mentioned areas, charities which have been established for more than one financial year and who can provide a full set of their most recent reports and accounts, or if their annual income is under £25,000. The Trust wishes to engage in long term support, funding on an annual basis and grants are made towards core funding and not for special projects or sponsorship proposals. **Applications may be submitted at any time.**

Younity – Powering Communities Fund (UK)

Through the Powering Communities Fund, Younity provides grants of up to £3,750 to support community energy groups and organisations to start or improve their community energy projects. Applications which focus on creating social impact are particularly welcomed, such as creating a resource for the local community, running an event for young people, or starting a community garden. The funding can be used to cover the costs of equipment, local events or workshops, staff, volunteer training, and developing a local service or venue. **Applications can be submitted at any time.**

Angling Improvement Fund (England)

The Angling Trust is the organisation that represents all game, coarse and sea anglers and angling in England and Wales. The Angling Trust, supported by the Environment Agency has launched the Angling Improvement Fund which re-invests part of the proceeds of coarse, trout and eel fishing licence sales in England in projects that directly benefit anglers. The types of projects supported include: Fish protection and predation management; Spring Maintenance and fishery improvements; Health and Wellbeing benefits for older people. **Applications can be submitted at any time.**

Sanctuary Group - Community Investment Fund (England & Wales)

The Community Investment Fund offers up to £1,000 for projects which aim to make a difference to the lives of the residents and their communities. Applications for funding will fall in to the following categories: Employment, Education, Skills and Training; Health and Wellbeing; Community safety and infrastructure; Environment; Financial inclusion. Projects will have a community focus and be open to, and inclusive of all; and benefit a significant number of Sanctuary residents. **Applications can be submitted at any time.**

The Prospector - Idea Fund (UK)

The 'I've got an Idea Fund' by The Prospector supports individuals or small groups with innovative technological ideas that aim to deliver social or environmental benefits. Grants range from £250 to £3,000 and are for making and testing ideas. Only DIY projects are funded. **Applications can be submitted at any time.**

National Community Lottery Fund: Reaching Communities Fund

The Reaching Communities programme has new priorities (since 1 April) which will help the funder to deliver its missions and create fairer, stronger, more resilient futures for communities - projects that: support places, people or communities experiencing poverty, disadvantage or discrimination; and support people and communities to shape the decisions that affect their lives. Alpkit Foundation Funding Opportunity (England)

Our trustees review applications every two months, offering small grants (£50-£500) to individuals, community groups, schools, and organisations. We fund projects that encourage outdoor activity, support environmental initiatives, promote wellbeing, and enhance outdoor education. Apply at least 3 months before your project starts. Multiple applications are welcome, provided they meet our funding criteria. We support:

- Outdoor participation & education (e.g., First Aid, Mountain Leader Training)
- Conservation & environmental projects
- Diversity, inclusion, and wellbeing initiatives

We do not fund holidays, charity challenges, or retrospective applications. **Apply at any time.**

Sport England - Movement Fund (England)

The Movement Fund by Sport England provides crowdfunding pledges, grants, and support for projects that aim to increase physical activity. Eligible projects can receive up to £15,000 to provide physical activity opportunities for the people and communities who need it the most. The grants can be used to cover a wide range of costs and items that will help deliver positive change, particularly for those facing barriers to activity. **Applications can be submitted at any time.**

HS2 Community and Environment Fund (England)

The HS2 Community and Environment Fund (CEF) has been established to offset the disruption caused to local communities throughout the construction phase of HS2. The aim of the CEF is to award grants of up to £75,000 to projects that will benefit communities along the route. Supported projects could include, for example: Pedestrian, equestrian or cycle access; landscape and nature conservation / enhancement; enhancement / replacement of sports and recreational facilities; refurbishment / re-use of historic buildings and monuments. Capital and revenue costs can be funded.

Applications can be submitted at any time.

National Lottery Heritage Grants

Guidance and application forms to apply for a **National Lottery Heritage Grant** under their new **10-year strategy, Heritage 2033** have now launched on their website. Organisations can apply at any time for grants £10,000 - £250,000. To get feedback and advice before starting an application, applicants can submit a **Project Enquiry**. Organisations can also apply for grants £250,000 - £10million, but must first submit an **Expression of Interest** and, if successful, will be invited to apply. 4 **investment principles** guide all grant decision making and must take all principles into account:

- saving heritage
- protecting the environment
- inclusion, access and participation
- organisational sustainability

National Lottery Grant Schemes - The National Lottery has two regular community grant schemes which are ongoing (**no firm deadline**).

- **Awards for All**: Offers grants between £300 and £20,000 for up to 2 years.
- **Reaching Communities**: Offer grants from £20,001 for up to 5 years.

Both programmes fund projects or organisations that will do at least one of these things:

- bring people together to build strong relationships in and across communities.
- improve the places and spaces that matter to communities.
- help more people to reach their potential, by supporting them at the earliest possible stage.
